Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. Buyer Added text based ATC clauses

Clause 5.5.1 may be read as

Payment of all works, print creative/display creative/marketing collaterals/TV commercials/short-films/any other work under this Project by Selected Agency will be based on the discovered rates, post finalization of this RFP.

In case, selected agency has quoted higher rates for any specific work (wherein prevailing BOC rates are available), the work shall be awarded at BOC rate only.

Clause 2.4.4 (w) may be read as

In cases of organizing events wherein transportation cost and expenditure incurred on stay is involved, following rates will be admissible:

Travel to the from Delhi	visiting c	tyUpto 500 km, travel in train by AC III Tier/Standard Chair Car or actual travel by any other mode whichever is less.
		More than 500 km, travel by AIR (Economy Class). The booking of economy class in case of AIR travel must have flight having the Best Available Fare which is the Cheapest Fare available preferably for Non-stop flight in a given slot (slots of three hours starting from 00:00 hrs to 03:00 hrs to 21:00 hrs to 24:00 hrs), at the time of

	booking. The print-out of the concerned webpage having flight and fare details may be retained for reimbursement purpose.
Stay at Hotel	Rs.3500/- per day upto a maximum of 3 days for a particular event or actual rate of lodging whichever is less.

The above reimbursements are subject to production of original bill as per the entitlements mentioned above.

All other clauses of the earlier uploaded RFP/Bid Document shall remain valid.
