**Aadhaar authentication crosses the landmark 150 bn transactions number, powering India's digital economy and welfare services**



## UIDAI achieves major milestone with over 150 billion Aadhaar authentications

The total number of Aadhaar authentication transactions has crossed 150 billion mark, making it a milestone moment in the journey of the Unique Identification Authority of India (UIDAI) and for the broader Aadhaar ecosystem.

The landmark highlights the extensive usage and utility of Aadhaar, and the growth of digital economy in the country. Ministry of Electronics and IT in a statement said that the cumulative number was achieved by the end of April 2025, since its inception.

The Ministry added that in April alone, almost 210 crore Aadhaar authentication transactions were carried out which is nearly eight percent more than the same month in 2024. It added that Aadhaar-based authentication has been playing a stellar role in aiding ease of living, in effective welfare delivery, and in voluntarily availing various services offered by service providers.

Aadhaar e-KYC service continues to play a key role in improving customer experience and adding ease of doing business in sectors including banking and non-banking financial services. Besides, more than 100 entities both in government and private sector, are using face authentication for smooth delivery of benefits and services.



## Aadhaar Authentication Crosses 150 Bn: Centre

Aadhaar authentication transactions crossed 150 billion by the end of April 2025, the government said on Friday. The landmark figure, equivalent to over 15,000 crore transactions, points to Aadhaar's central role in enabling digital services and streamlining welfare delivery.

In April alone, approximately 2.1 billion authentication transactions were recorded, an 8 per cent increase from the same month last year, highlighting rising reliance on the system for accessing services and benefits.

Aadhaar's e-KYC (electronic Know Your Customer) functionality also reported robust growth. Nearly 373 million e-KYC transactions were conducted in April, a surge of nearly 40 per cent compared with April 2024. The cumulative e-KYC count has now exceeded 2.39 billion, reflecting its growing importance in banking, finance, and other customer-facing sectors.

UIDAI's AI-driven face authentication technology is seeing increasing adoption as well, with 140 million face-based transactions recorded in April. Over 100 entities from both government and private sectors are now using face authentication for service delivery, according to the authority.
