**CIRCULAR**

Sub: **Minimum number of Aadhaar Enrolment and Update to be done by Banks -  
Revision of targets- reg**

- Ref: 1. Notification No.13012/79/2017/Legal-UIDAI ( No. 4 of 2017) dated 14 July 2017.  
2. Circular No. 4(4)/57/341/2017/E&U dated 29.04.2019.

Vide notification no. 13012/79/2017/Legal-UIDAI ( No. 4 of 2017) dated 14 July, 2017 issued under Aadhaar (Enrolment and Update) Regulations, Banks were mandated to setup Aadhaar enrolment and update facility inside its bank premises at a minimum of 1 out of their every 10 branches by 30<sup>th</sup> August 2017.

2. Accordingly, based on the number of branches, the target to be achieved by each bank had been revised vide circular referred above.

3. Consequent to opening/closure of branches, amalgamation of banks, changes in the number of RRBs etc. there was request to revise the targeted number of centres from different banks. Accordingly, the revised target fixed for each bank is attached as annexure -I.

4. Considering the overall achievement of target by banks during pre-corona period, low footfall for Aadhaar activities in some areas and the present pandemic situation of Covid-19 etc., the Competent Authority approved the proposal to relax the financial disincentive for not achieving the target (@Rs. 20,000/- per branch) of 8 enrolment/update transactions per day per branch up to 30<sup>th</sup> September, 2020.

5. Accordingly, based on the requests received from various banks to waive the Aadhaar Authentication and E-KYC service charges, considering the national lockdown and social distancing norms to be followed at the enrolment centres, it is decided to waive the charges from 01.03.2020 to 30.06.2020.

6. For the purpose of pricing of Aadhaar Authentication Services to be charged from 1<sup>st</sup> July 2020 onwards, the targeted numbers will be applicable as follows.

- i) From 01.07.2020- 30.09.2020 - Minimum 4 transactions per day per branch as per the revised target.
- ii) From 01.10. 2020 onwards - Minimum 8 transactions per day per branch as per the revised target.

7. In case bank fails to meet the above target of carrying out minimum enrolment /update per day per branch, financial disincentive in respect of uncovered branches as on last day of the month will be levied from the month of October 2020 onwards.

8. This issues with the approval of CEO, UIDAI.
