## **SCOPE OF THE WORK:**

- a. Supply, Installation, Testing and Commissioning of One Tally Server 9 Software at UIDAI Headquarter, New Delhi with Multiple users (Minimum 30) across all the offices of UIDAI (Regional Offices) and related services for a period of One Year including Software upgradation/Training.
- Two years (2) Annual Maintenance Contract for product support at site & offsite, Telephonic support and Tally Net Subscription for Multiple users (Minimum 30) after completion of one Year.

#### Terms and conditions for bidders

## 1. Bidders Eligibility:-

- 1.1 The bidder must possess a valid certification/license from OEM with 5(Five) Star rating distributor/dealer/Channel Partner based in Delhi.
- 1.2 The bidder should have executed at least two similar work orders within last three Years prior to the date of Bid submission in any of the Govt/Semi Govt. Departments/Autonomous institutions/Universities/ Public Sector Undertaking of the Government of India or any other State Government (Enclose client certificate/Copy of Purchase Order/final payment particulars).
- 1.3 Bidder should not have been blacklisted by any Central/State Government or Central/State Govt. PSU or other institution in India. An undertaking to this effect shall be submitted by the bidder.
- 2. The bidder shall bear all costs associated with the preparation and submission of the bids and UIDAI, HQ in no case shall be responsible or liable for those costs, regardless of the conduct or outcome of the tender process.
- 3. Bidders shall submit the following documents:
  - a. Bid Security (EMD) of Rs. 15,000/- (Rupees Fifteen thousand only) and Tender Fee of Rs. 100/-(Rupees One Hundred only) in the form of DD (Demand Draft) issued by any Nationalized bank in favour of **"UIDAI"** payable at New Delhi.
  - b. Exemption of Tender fee & EMD would be applicable to those bidders who have MSME Registration/Start-up Registration with Department of Industrial Policy and Promotion (**DIPP**) as per GFR-2017.
  - c. Self-attested copy of the GST/PAN of the Bidder.
  - d. Self attested copy of letter/certificate/undertaking from OEM (Original Equipment Manufacturer) authorizing the Bidder as 5(Five) Star rating distributor/dealer/Channel Partner valid for a period of at least three Years from the last date of bid submission.
  - e. Self attested copy of valid proof of Office Address/ Service Centre in Delhi.
- 4. The last date of submission of bids will be on **22.02.2019 at 3.00 PM** and the bid will be opened on the same day at 4.00 PM. Interested bidder or their representatives may attend at their own expanses, if desire so. The bid security of the unsuccessful bidder shall be returned within a week time after finalization of the contract.
- 5. The Validity of bids shall be 45 days from the date of bid submission.
- 6. Any tender not accompanied by Bid Security/Tender fee shall be rejected **OR** relevant certificate to claim exemption as per Govt. Norms.
- 7. Conditional bids will be summarily rejected.
- Bid Security shall be forfeited if the bidder withdraws his/her bid prior to the date of Bid Opening.

- 9. All rates shall be quoted separately for each component of the Software inclusive of all taxes & duties.
- 10. The bidder shall submit the bid signed on each page along with requisite documents as specified in the tender document including "EMD & Tender Fee" in a sealed envelope superscripted "Supply & installation of Tally Server 9 Software in UIDAI HQ" and shall be addressed to SO (Admin II) at 4<sup>th</sup> Floor, Aadhaar UIDAI HQ, New Delhi-110001. Bids submitted late shall not be entertained.
- 11. The bidders qualifying the eligibility criteria will be considered for financial evaluation. The Bidder quoting the overall lowest price will be awarded the work. If there is a tie (overall quoted), in such case, preference will be given to the bidder executing max volume of work (in amount) within last three Years prior to the date of Bid submission, UIDAI may seek clarification at any stage of the bidding. Decision of UIDAI shall be final and no representation shall be entertained.
- 12. The contract will be awarded to the firm/agency quoting the overall lowest price ("X" + "Y") which is referred under techno-commercial bid at Sr. No.10 (3).
- 13. A sum of 10% of the total contractual values will be kept as performance guarantee. The successful bidder shall be required to furnish the performance bank guarantee from any Nationalised Bank/ Cash/Demand Draft to Deputy Director (Admin) within seven days of the receipt of the offer. The performance guarantee shall be returned after 60 days of completion of the contractual period without any interest.
- 14. The bidder shall supply the software within a period of 07 days after acceptance of the work order.
- 15. The supplier will install and Test the software for all the Multiple Users throughout UIDAI Offices from the installation site (UIDAI HQ) within 15 days of the supply of the software.
- 16. Bid Security shall be forfeited if the successful bidder refuses or neglects to execute the contract within the time frame.
- 17. Payment for Supply, Installation, Testing and Commissioning shall be within a week after receiving certificate of successful execution from user wing (DDO/ADG-Account) and submission of bills complete in all respect.
- 18. Payment of AMC would be made within a week time after interval of Six months with certification of satisfactory performance from the user wing and submission of bills complete in all respect.
- 19. Any other information/details may be obtained from Sh. Mohit K Goyal, SO (Admin), at 4<sup>th</sup> Floor, Aadhaar UIDAI HQ, Gole market New Delhi-110001 on any working day between 10:00 A.M. to 5:00 P.M. Interested parties may, if they so desire, visit the site personally on all working days.
- 20. The competent authority of UIDAI headquarter reserves the right to reject any bid or all bids without assigning any reason.

- 21. Liquidated Damages (LD): If the contractor is unable to complete the supply within the stipulated time limit, UIDAI at its discretion may allow additional time as justified with/without penalty and without altering terms and conditions of the bid. In the event of failure of the contractor to complete the supply within the stipulated time or the extended time, UIDAI has the right to impose Liquidated Damages @ 1.0% of the Contractual Value per week or part of the week. The Contractor's liability for delay, however, shall not exceed 10% of the total contract value.
- 22. The successful bidder shall extend the services as per the requirement of users during the currency of AMC and shall attend the fault within three hours after reporting. In case of failure, UIDAI may impose a penalty of Rs. 500/- for each three hours delay, it would become double after 12 Hrs and UIDAI may cancel the AMC if the fault continues beyond 48 Hrs or have a right to repair from outside at the cost of successful Bidder. In case of AMC cancellation, UIDAI will recover all dues by encashing PBG.
- 23. Violation of any terms & condition during warrantee period may invite forfeiture of performance of Bank Guarantee.
- 24. All the disputes are within the jurisdiction of Delhi.
