NOTICE FOR EMPANELMENT OF PRODUCERS/PRODUCTION HOUSES FOR AUDIO-VIDEO FILMS/SPOTS

The Unique Identification Authority of India invites applications in the prescribed proforma for empanelment of producers/production houses in two categories for producing video films/spots and audio programme for a period of three years. **Please go through the full documents available at http://uidai.gov.in/**.

1. Eligibility criteria for empanelment are as follows:

2. In addition to the above, those producers/production houses wishing to be considered for empanelment as A/V producers in Category A should have produced at least 10 good quality A/V programmes in the past 3 years. Those producers/production houses wishing to be considered for

empanelment in Category B should submit at least 3 good quality A/V programmes in the past 2 years. Experience in both fiction/non fiction genres is highly desirable. Furthermore, greater merit will be given to those producers/production houses who have worked in various regional languages.

The show reels should be submitted in video/digital CD (VCD/DVD) format or in USB sticks. The producer will have to produce documentary evidence of production done, such as, a copy of the work order, satisfactory completion of assignment and payments received etc.

- 3. No request for sending the application proforma or other documents by post shall be entertained. The application complete in all respects, should be submitted along with a demand draft. Category A producers will submit along with her/his applications a demand draft of Rs. 10,000 (non-refundable), Category B producers will submit a demand draft of Rs. 5,000 (non-refundable) drawn in favour of 'UIDAI, New Delhi' payable at New Delhi as processing fee.
- 4. The application along with the demand draft should be submitted to the UIDAI Headquarter by 1600 hours on the **3rd March**, **2011**. The address is as follows:

SELECTION CRITERIA FOR EMPANELMENT OF PRODUCERS/PRODUCTION HOUSE OF FILMS/AUDIO-VIDEO SPOTS AND PRODUCTION THEREON

UIDAI's Mission

The unique identification number (Aadhaar) will be a nationally valid proof of identification that will be issued by the UIDAI to all residents in the country. The number will be:

- a) verifiable in an online, cost-effective manner
- b) based on biometrics
- c) robust enough to eliminate duplicate and fake identities in databases.

The impact of the UIDAI initiative will be wide-ranging. For residents across the country, Aadhaar will be a transformational number which will improve the delivery of welfare programs and will provide residents, particularly the poor, greater access to resources and services. Enrolment for the number will be through registrars across the country that the Authority will partner with. Such registrars may include State Governments, PSUs, banks etc. These registrars may in turn, partner with enrolling agencies to enroll residents into the UIDAI database.

The Unique Identification Authority of India (UIDAI) wishes to empanel a limited number of good performing producers for the work of production of films/audio-video spots for the publicity of programmes, policies and other activities of the Authority and its 8 regional offices under the guidelines specified herein.

GENERAL

- 1. The selection criteria shall come into force with immediate effect.
- 2. An Empanelment Committee (EC) will be constituted to consider the applications of A/V producers and recommend those having requisite qualifications for empanelment. The EC will evolve its own procedure for scrutiny of applications, screening of show reels for quality assessment etc.
- 3. The composition of Empanelment and Costing Committee (EC) shall be as under:

a.	Deputy Director General, UIDAI	Chairman
b.	Additional Director General, UIDAI	Member-Secretary
c.	Head – IEC, UIDAI	Member
d.	Nominee – Finance, UIDAI	Member
e.	Nominee - Doordarshan (Programming)	Member
f.	Nominee - Doordarshan (Technical)	Member

The Committee is empowered to co-opt up to 2 additional members having experience in this field, if necessary.

ELIGIBILITY CRITERIA

- 4. The Unique Identification Authority of India proposes to empanel A/V producers in 2 categories: A and B.
- 5. Only such producers who have adequate qualifications, experience and capabilities to produce good quality A/V programmes in required formats will be eligible to apply for empanelment.
- 6. Eligibility criteria for empanelment are as follows:

7. Awards that will be considered by the EC include (i) Cannes Lions International Advertising Festival, France (Golden Lion, Silver Lion, Bronze Lion) (ii) American Advertising Federation, USA (Golden Addy, Silver Addy, Bronze Addy) (iii) Mobius Advertising Awards, California,

USA (Best Commercial, Best Recreation, Public Service) (iv) Clio Awards, MIAMI, USA (Best Ad Agency, Best Director, Best Art Director, Best Producer) (v) Top Awards by Advertising Agencies Association of India (AAAI) in product categories, (vi) 'ABBY' Award, India (vii) Such other awards as may be notified by the Ministry of I&B. These awards should be awarded to the Central creative team of producers/production houses. The producers/Production houses need to submit in writing the availability of the central creative team during the entire tenure for which empanelment is being done.

- 8. In addition to the above, those producers wishing to be considered for empanelment as A/V producers in Category A should have produced at least 10 good quality A/V programmes in the past 3 years. Those producers/production houses wishing to be considered for empanelment in Category B should submit at least 3 good quality A/V programmes in the past 2 years. Experience in both fiction/non fiction genres is highly desirable. Furthermore, greater merit will be given to those producers/production houses who have worked in various regional languages.
- 9. No request for sending the application proforma or other documents by post shall be entertained. The application complete in all respects, should be submitted along with a demand draft. Category A producers will submit along with her/his applications a demand draft of Rs. 10,000 (non-refundable), Category B producers will submit a demand draft of Rs. 5,000 (non-refundable) drawn in favour of 'UIDAI, New Delhi' payable at New Delhi as processing fee.

APPLICATION

- 11. All applications shall be required to be submitted in the prescribed proforma along with the required information/documents/material.
- 12. The producer shall be required to submit copies of income-tax returns of last 2 financial years for (2008-2009 and 2009-2010).
- 13. The producer should also submit its balance sheets and profit and loss accounts of her/his firm/company, for the three preceding financial years; duly verified by a Chartered Accountant (indicating membership number of the Chartered Accountant in his seal).
- 14. Only full-time producers may apply for empanelment.

- 15. The producer will submit the CVs of her/his creative team. The producer will also submit documentary proof of ownership/retainership of production facilities, if any.
- 16. The producer will submit a certificate to the effect that the information submitted by her/him is correct and she/he will abide by the decision of UIDAI regarding empanelment. In case the information submitted by her/him is found to be false or fabricated in any manner, she/he may be debarred from empanelment.
- 17. The producer or her/his representative may be required to make a presentation before the EC at her/his own cost.

OTHER CONDITIONS

- 18. No producer will be eligible to have empanelment in more than one name (either in her own name or in the name of her/his close relative) or subsidiary firm/sister company.
- 19. The production procedure will be intimated separately to the empanelled producers.
- 20. The EC may debar producers from the panel on the basis of reasons to be recorded in writing.
- 21. Empanelment shall be valid for a period of three years. If the performance of any of the empanelled producers is outstanding (as judged by UIDAI), their tenure of empanelment may be extended by one year. If the performance of any of the empanelled producers is poor, they may be debarred.
- 22. Any producer blacklisted by the DAVP or Doordarshan/AIR will not be admitted for empanelment and if already empanelled will be liable for debarment.
- 23. UIDAI reserves the right to accept or reject any empanelled agency partly or wholly.
- 24. It may be noted that empanelment does not guarantee work orders.
- 25. Any dispute arising during the selection process will be resolved by the EC for reasons to be recorded in writing. The EC's decision will be final and binding.

- v. Please attach sheets wherever necessary.
- vi. All the enclosures should be properly annexured and serial numbered.
- vii. Please ensure that application form is complete. Incomplete application forms will not be considered. Last Date for submission of complete application in prescribed proforma along with relevant documents, show reels and demand draft shall be within twenty one days (before 1500 hours) from the date of publication of the notice. In case the last date happens to be a holiday the next working days shall be considered as the last date.
