7. Payment Terms

- 7.1 Payment shall be made only after completion of supply, installation commissioning and acceptance of the Goods above, to the entire satisfaction of UIDAI or any other agency nominated by UIDAI.
- 7.2 The UIDAI may however, consider making advance payments which shall be subject to the following conditions:
 - An advance payment equivalent to 25% of the total value of the Goods and Services against proof of despatch subject to the Vendor furnishing a bank guarantee on stamp paper of requisite value of an equivalent amount from any of the Nationalised/Scheduled Bank to indemnify Purchaser to the extent of any loss or damage sustained, in case the acceptance tests carried out on the Goods at the time of commissioning them in the SAN systems are not satisfactory.
 - ii) The Bank Guarantee to cover 25% of the invoiced amount to be executed, shall remain valid till 30 days beyond the system is finally accepted.
 - iii) 50% payment within 30 days of delivery and installation of system.
 - iv) Balance 25% payment within 30 days of satisfactory commissioning and acceptance of the Goods/Services. In case the commissioning and acceptance of the Goods/Services is delayed or put off beyond 90 days of the receipt of the equipment at UIDAI's site due to express written instructions of the UIDAI, this amount may be released to the Vendor on his furnishing a necessary Bank Guarantee for an equivalent amount.
 - v) No payment shall, however, accrue until after the Performance Guarantee Bond in the form of a Bank Guarantee (BG), which shall be equal to 10 % of the value of the order, has been furnished. This BG shall be submitted by the selected Vendor within 10 days of issue of the firm purchase order by this office.
 - vi) It should be noted that installation, commissioning and acceptance, have to be duly certified by the ADG, Technology Centre, UIDAI, Bengaluru for release of payments as per 7(iii) and 7 (iv) above.

8. It should be noted that.

(i) For evaluation of lowest quotation, post warranty annual maintenance costs for two years shall be taken into account. The formula for determining the lowest evaluated bid (L1) will be as under

L1 = Lowest [A + B]

- (iii) The vendor will provide the acceptance testing schedule at least 15 days before the due date of delivery.
- (iv) The vendor has to ensure that the name, address, date of delivery and stamp (of the office where delivered), are clearly visible on the duly signed proof of delivery.
- (v) Any unjustified and unacceptable delay in delivery beyond delivery schedule will render the vendor liable for damage at the rate of 0.2% (zero point two percent) per day subject to a maximum of 40 days and thereafter UIDAI holds the option for cancellation of the order and forfeiture of performance and impose cancellation charge of 10% of the order value.
- (vi) The Systems ordered should be installed immediately on delivery or latest within **30 days** from the purchase order whichever is earlier.
- (vii) Any delay in installation of delivered item(s) attracts a penalty of Installation Penalty Percentage 0.2% of PO value per day subject to a maximum of 40 days from due date of installation. Therefore, UIDAI holds the option to complete installation work through alternate sources at the risk and cost of the defaulting vendor.
- (viii) The items supplied would be under Three Years Comprehensive Warranty and free support service from the date of installation and acceptance, including free provision of spare part, kits as and when necessary The vendor should fulfill the following condition during the warranty period:
 - (a) Any failure in the system or a subsystem thereof should be rectified within maximum period of 4 hours of lodging complaint.
 - (b) If any of the system/subsystem is down beyond 4 hours, penalty will be charged per hour per system/subsystem at the rate of Rs.1000/-(Rupees One Thousand Only.)
