- 1. The rates quoted, should clearly specify whether Sales Tax, Central Sales Tax and Service Tax and VAT are applicable and, if so, at what rate? In case, this information is not indicated in the quotation, it would be presumed that the rates quoted are inclusive of all type of taxes.
- 2. The period of contract shall be for one year initially from the date of award of the contract and shall remain valid until the completion of the obligations of the parties under the contract. The contract shall initially be effective for a period of one year, extendable to further two years on year to year basis, subject to satisfactory performance of the firm and administrative decision of UIDAI. The bidder will have to supply the mineral water in the office of UIDAI Headquarter at 2nd Floor & 9th Floor, Tower-I and 3rd Floor, Tower-II, Jeevan Bharti Building, Connaught Circus, New Delhi-110001. No transportation charges will be paid.
- 3. Any modification in offer after the opening date will not be considered. No request for escalation in rate shall be entertained on account of any reasons during the period of the contract.
- 4. The UIDAI headquarter reserves the right to seek clarification or verification of any information supplied by the bidder.
- 5. The estimated quantity to be given on every day basis at the above mentioned buildings/ locations may vary depending upon the climate and the requirement.
- 6. Payment shall be made by electronic transfer to the account of the supplier after completion of each month on submission of pre-receipt bill in triplicate on monthly basis.
- 7. EMD of Rs.15000/- (Rupees Fifteen Thousand only) must accompany by way of DD/Pay Order in favour of Pay and Accounts Officer, UIDAI payable at New Delhi. A quotation not accompanied by EMD will be summarily rejected.
- 8. EMD of successful bidder will be returned after he/she submit the performance security (PBG) i.e. 10% of total contractual value which will be refunded on satisfactory completion of the contract. No interest will be paid on Security Deposit.

In case of frequently supply of such water, the contract will be cancelled forthwith and Security Deposit forfeited. The Firm will also be black-listed.
- 14. If the service rendered by the firm is not found satisfactory at any time during the period of contract, the contract is liable to be cancelled without any notice.
- 15. Dispute, if any, arising in the matter shall be settled by an arbitrator to be nominated by the UIDAI Headquarter, New Delhi.
- 16. The contract shall be subject to Indian Laws and the jurisdiction of Delhi Court.
