Section 3: Introduction

Government of India has set up Unique Identification Authority of India (UIDAI) with the mandate to issue Unique Identification Numbers (UID) to all residents of India (UID Project). In order to implement the UID project in the State of Punjab, the Government of India has entered into a MoU with UIDAI.

The Government of Punjab has set up State Level UID Implementation Committee to oversee the implementation of the UID project in the state. Government of Punjab has notified Department of Food, Civil Supplies and Consumer Affairs Department as its State Registrar.

State is trying to complete the Aadhaar enrollments and efforts are being made to complete 100% enrollment in near future. Department of Food, Civil Supplies and Consumer Affairs intends to procure Laptops, UPS, Printers, LED Monitors, Biometric devices, Webcams, Android Tablets, Spike suppressors, External HDDs and USB Hubs which will be commissioned at Suwidha Centers and will further be used in the field across the state for conducting pending Aadhaar enrollments of residents under the UIDAI Project.

Section 5: Instructions to Bidders

5.1. Due Diligence

Bidder is expected to examine all instructions, forms, terms and specifications in this tender document. Bid shall be deemed to have been submitted after careful study and examination of this document with full understanding of its implications. The bid should be precise, complete and in the prescribed format as per the requirement of this Tender document. Failure to furnish all information required by this document or submission of a bid not responsive to this document in every respect will be at the Bidder's risk and may result in rejection of the bid.

5.2. Cost of Form / Bid document

- 1) All bidders are required to pay Rs. 5,000/- (Rupees Five Thousand only) through online mode only provided on the Punjab Infotech e-tendering portal as a form fee. This is per category wise bid cost.
- 2) Form fee is non-refundable.
- 3) Form fee must accompany the Qualification bid.
- 4) Each Form fee is separate per category and single form fee cannot be clubbed for multiple categories.

Note: Tender Processing fee is separate which needs to be paid to the Punjab Infotech.

5.3. Earnest Money Deposit

- 1) An EMD of Rs. 5, 00,000/- (Rupees Five Lakhs only), to be made through online mode only and this will be per category cost.
- 2) Bid not accompanied by EMD shall be rejected as non-responsive.
- 3) No interest shall be payable for the sum deposited as earnest money deposit.
- 4) No Performance Bank Guarantee will be accepted in lieu of the earnest money deposit.
- 5) The EMD of the unsuccessful bidders would be returned back within 90 days of signing of the contract with the selected bidder and this will be made offline
- 6) The EMD must be submitted through online mode only provided on the e-tendering portal of Punjab Infotech
- 7) The EMD may be forfeited:

- If the Bid is withdrawn after submission but before award of the contract to the successful Bidder during the validity period or any extension agreed by the Bidder thereof.

5.4. Performance Bank Guarantee

Performance Bank Guarantee equivalent to 15% of the total contract value rounded off to the nearest thousand Indian Rupees from a Scheduled Bank in India in favour of Registrar, UID, Punjab. It should be in the form of an unconditional, irrevocable and continuing Bank Guarantee as per the Section 13.9 and would remain valid until 36 months after submission of invoice against the first milestone as described in Payment terms (10.1) of this document. The claim period and other details of the Performance Bank Guarantee are as per Section 13.9 of this document. The Performance Bank Guarantee shall be submitted within 15 (fifteen) days of submission of invoice to Registrar, UID, Punjab.

85% payment against the first milestone will be released after due documentation as described in Section 10 of this document. Remaining 15% payment shall only be released after submission of valid performance bank guarantee as mentioned above. Performance Bank Guarantee would be returned only after adjusting/recovering any dues recoverable/payable from/by the Bidder on any account under the contract.

EMD of successful bidder will be returned on the submission of performance bank guarantee.

5.5. Language of Bid

The bid prepared by Bidders, as well as all correspondence and documents relating to the bid exchanged by the Bidders and Registrar, UID, Punjab shall be in English.

5.6. Bid Currencies

Prices shall be quoted in Indian Rupee (INR). All payments / deposits / fees with respect to this tender shall be in Indian Rupee only.

5.7. Consortium

The Bids submitted by consortium of companies/firms will be rejected.

Excel sheet category wise will be available on the e-tendering portal and bidder needs to enter the price and save it online. No scanned copies will be entertained for the commercial bid.
- 2) Bidders should necessarily give the financial details as per the Format 12.2, category wise and bidder needs to enter the price and upload the same document online. No scanned copies will be entertained for the commercial bid.
- 3) All the financial details should be given in the prescribed format only and in accordance to the details / terms and conditions as mentioned in this document.
- 4) In case the selected Bidder misses to include the cost of any hardware / software / service which is necessary to meet the requirements of this tender document, he shall be solely responsible for the lapse and would be required to provide such hardware/software/services without any additional cost to Registrar, UID, Punjab.

- 3) Bidder can change the bid any number of times before the last date of tender submission.

5.13. Rejection of Bid

- 1) The bid has to be submitted via e-tendering portal hosted by Punjab Infotech https://etender.punjabgovt.gov.in. Bids submitted by telex, fax, hard copies or email etc. shall not be entertained.
- 2) Any condition put forth by the Bidders not conforming to the bid requirements, shall not be entertained and such bid shall be rejected.

5.14. Disqualification

Registrar, UID, Punjab may at its sole discretion and at any time during the evaluation of application, disqualify any Bidder, if the Bidder:

- 1) Made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements.
- 2) Submitted an application that is not accompanied by required documentation or is non-responsive.
- 3) Failed to provide clarifications related thereto, when sought.
- 4) Submitted bid only for single item and not for the complete category
- 5) Was declared ineligible/blacklisted by any Govt. or quasi-Govt. entity in India.

5.15. Conflict of Interest

Neither the successful Bidder nor any Personnel related to it shall engage, either directly or indirectly, during the period of contract, in any business or professional activities which would conflict with the activities assigned to them under or pursuant to this tender.

5.16. Confidentiality

The Bidder and their personnel shall not, either during the term or after expiration of this contract, disclose any proprietary or confidential information relating to the services, contract or the Registrar, UID, Punjab/Suwidha Centers or operations without the prior written consent of the Registrar, UID Punjab.

5.17. Extension of Last date for Submission

Registrar, UID, Punjab, at its own discretion can extend the period for submission of bids by amending the Bid Documents through the online e-tender portal. In this case all rights and obligations of Registrar, UID, Punjab and Bidders shall stand extended. However, no request for extension of time from the Bidders shall be binding upon Registrar, UID, Punjab. The decision of Registrar, UID, Punjab in this behalf will be final, conclusive and binding on the Bidder.

5.18. Late Bids

Any bid received by Registrar, UID, Punjab after the deadline for submission of bids prescribed in this Tender document will be summarily rejected. No further correspondence on this subject will be entertained.

5.19. Modification and Withdrawal of Bids

Bid can be modified multiple times before the closure of the tender. No bid may be withdrawn in the interval between the deadline for submission of bids and the expiration of period of bid validity specified by the Bidder. Withdrawal of a bid during this interval will result in the Bidder's forfeiture of its EMD.

5.20. Duties, Taxes and Statutory levies

- 1) The Bidder shall bear all personal taxes levied or imposed on account of payment received under this Contract.
- 2) The Bidder shall bear all corporate taxes, levied or imposed on account of payments received from Registrar, UID, Punjab for the work done under this Contract.
- 3) Bidder shall bear all taxes and duties etc. levied or imposed under the Contract including but not limited to Sales Tax, Customs duty, Excise duty, Octroi, Service Tax,

VAT, Works Contracts Tax and Income Tax levied under Indian Income Tax Act – 1961 or any amendment thereof up to the date for submission of final price bid, i.e., on account of payments received by him for the work done under the Contract. It shall be the responsibility of the Bidder to submit to the concerned tax authorities the returns and all other connected documents required for this purpose. The Bidder shall also provide Registrar, UID, Punjab such information, as it may be required in regard to the Bidder's details of payment made by the Purchaser under the Contract for proper assessment of taxes and duties. The amount of tax withheld by Registrar, UID, Punjab shall at all times be in accordance with Indian Tax Law and will furnish to the Bidder original certificates (Challans) for tax deduction at source and paid to the Tax Authorities.

- 4) If there is any reduction in taxes / duties due to any reason whatsoever, after Award of Contract, the same shall be passed on to Registrar, UID, Punjab.
- 5) The Bidder shall be solely responsible for the payment /fulfillment of its tax liabilities and obligations under the Income Tax Act and other such laws in force and Registrar, UID, Punjab shall not bear responsibility for the same.

5.21. Deductions

All payments to the Bidder shall be subjected to the deductions of tax at source under Income Tax Act, and other taxes and deductions as provided for under any law, rule or regulation. All costs, damages or expenses which Registrar, UID, Punjab may have paid or incurred, for which under the provisions of the Contract, the Bidder is liable; the same shall be deducted from the Bidder. Registrar, UID, Punjab shall if so required by applicable laws in force, at the time of payment, deduct income tax payable by the Bidder at the rates in force, from the amount due to the Bidder and pay to the concerned tax authority directly.

5.22. Right to Accept/Reject the Bid

Registrar, UID, Punjab reserves the right to accept or reject any Bid and to annul the Tender process and reject all such bids at any time prior to award of contract, without thereby incurring any liability to the affected Bidder(s) or any obligation to inform the affected Bidder(s) of the grounds for such decision.

Section 6: Bid Evaluation Process

6.1. Pre-Bid

Pre bid meeting will be conducted on 06/01/2016 at the office of Registrar, UID, Punjab, Anaaj Bhawan, Sector 39-C, Chandigarh at 12pm where all the bidders can participate and clear any of the queries by giving that in writing. In this meeting, Bidders are requested to bring the respective devices meeting the specifications of the hardware components, category wise for which they are bidding. Bidders can request for any clarifications and consolidated corrigendum (if required) will be released after the pre-bid meeting.

6.2. Opening of Bids

The Tender Evaluation Committee [TEC] duly appointed by Registrar, UID, Punjab will open all the Bids on the date decided to open the bids and bidders can view the bid online at their own locations through the online portal hosted by the Punjab Infotech. In event of date of Bid opening being declared a holiday for Registrar, UID, Punjab, Bids shall be opened at the same time and location on the next working day.

6.3. Evaluation of Qualification Bids

- 1) The Qualification Bids of Bidders, whose EMD is not in order shall be summarily rejected.
- 2) Bidders are required to fulfill all the Qualification conditions mentioned in Eligibility Criteria of this Tender document. Tender Evaluation Committee (TEC) will examine the Bids for their completeness and conformity to requirements of this document. Decision of TEC in this regard will be final and binding on all the bidders.
- 3) The Commercial Bids of disqualified Bidders will not be opened.

6.4. Evaluation of Commercial Bids

- 1) Registrar, UID, Punjab will select the successful Bidder through the Bidding Process on the basis of lowest total contract value (TCV), Category wise as indicated in the Commercial Bid submitted by the Bidder. No intimation would be sent to the unsuccessful Bidders. Category wise breakdown for the list of items along with the quantity is mentioned in Section 11 of this document.
- 2) In case of a tie where the Total Contract Value, Category wise of two or more Bidders

match, Bidder for category V1 who has quoted lowest unit price of Laptops (Sum of High end and Medium end)(L) as indicated in Commercial Bid submitted by the Bidder, will be declared L1. If (L) also matches, unit price of Monitor (M) will be compared; and the bidder with lower value of (M) as quoted in the Commercial Bid will be declared L1. If (M) also matches, the comparison of Printer (P), External HDD (H), USB Hub (UH), Web Cam (WC), Spike Suppressor (SS) and UPS (U2) will be done in that order to establish the L1.

- 3) For category V2, L1 will be declared based on the Total contract value for Iris Scanner and Finger Print Scanner. In case of tie for two or more Bidders for Category V2, Bidder quoting the lowest unit price for Iris Scanner (IS) will be declared as L1 and in case that matches, unit price of Finger Print Scanner will be compared. In case both matches, commercial bid will be done again between those bidders and Tender processing fee will have to be paid again by the bidder.
- 4) For Category V3, L1 will be declared based on the Total contract value for Android Tablets and Biometric Scanner. In case of tie for two or more Bidders for Category V3, Bidder quoting the lowest unit price for Android Tablets will be declared as L1 and in case that matches, unit price of Biometric Scanner will be compared. In case both matches, commercial bid will be done again between those and Tender processing fee will have to be paid again by the bidder.
- 5) In case L1, category wise is unable to or refuses to sign the Contract, EMD of L1 will be forfeited and re-tendering will be done in this case.
- 6) All the Prices, terms, warranties, and benefits provided in this contract should be comparable to or better than the terms presently being offered by Bidder to any other entity purchasing the same quantity under similar terms. If during the term of this contract, vendor enters into contracts with any other entity providing greater benefits or more favorable terms than those provided by this contract, Vendor shall be obligated to provide the same to the Registrar, UID, Punjab for subsequent purchases.

6.5. Waivers

Registrar, UID, Punjab may waive any minor informality or nonconformity or irregularity in a bid, which does not constitute a material deviation, provided. Such waiver does not prejudice or affect the relative ranking of any Bidder.

Section 7: Award of Contract

7.1. Notification to Bidder

Prior to the expiry of the Bid validity period, Registrar, UID, Punjab will notify the successful Bidder in writing or email that its proposal has been accepted. The notification of award, termed as Letter of Intent or LOI in sections to follow, will lead to signing of the Contract. Upon the successful Bidder's furnishing of performance bank guarantee, Registrar, UID, Punjab will promptly notify each unsuccessful Bidder online and EMD will be returned as per the clause mentioned in Section 5.3

7.2. Discharge of Bid Security

After the contract is awarded to the bidder, the selected Bidder shall supply the equipment within 6 weeks, failing which a penalty clause will be invoked as per Section 9.2. In case a successful bidder (L1) fails to deliver the complete consignment within 8 weeks of award of Contract -

- EMD of L1 will be forfeited.
- L1 will be blacklisted from participating in any Government of Punjab tendering process in future.
- Re-Tendering will be done

7.3. Signing of Contract

Registrar, UID, Punjab shall enter into a Contract, incorporating all Agreements, as specified in the draft contract provided in this document under Section 13.12, with the successful Bidder. Successful bidder shall sign the agreement within 15 days of award of contract.

7.4. Validity of Contract

The Contract / Agreement will be valid for a period of 36 months from the date of its signing. The contract may be extended for a further period at the same terms and conditions subject to mutual consent.

7.5. Expenses for the Contract

The incidental expenses of execution of Agreement/Contract shall be borne by the successful Bidder.

7.6. Failure to abide by the terms of contract

Failure of the successful Bidder to agree with the Terms & Conditions of the Contract shall constitute sufficient reason for the annulment of the award, in which event Registrar, UID, Punjab may forfeit the EMD/ Performance Bank Guarantee. Re-tendering will be done in this case.

Section 8: Scope of Work

8.1. Supply, installation and Commissioning of Infrastructure

Bidder shall be responsible for supply, installation, commissioning and maintenance of delivered products as per the minimum specifications and indicated quantities mentioned in this document under section 11. The supplied Laptops, UPS, Printers, External Hard Disk Drives, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams mentioned in this document should carry a 36-months comprehensive onsite warranty from the date of acceptance sign-off on its hardware and preloaded software and the license cost of any software renewal for a period of 36 months should also be part of submitted cost.

8.1.1. Delivery

Below specified quantities of Laptops, UPS, Printers, External Hard Disk Drives, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams etc. are to be delivered mainly at the office of Registrar, UID-Punjab, Chandigarh, DC and SDM offices throughout the state of Punjab. List of the same is attached in the Section 13.10 of this document. Category wise breakdown of all items is given in Section 11

- Actual quantity will be shared at the time of supply order.
- TCV will be calculated based on the above quantities, category wise which is mentioned in the section 11 for the purpose of award of contract.
- Payments will be made for the quantity actually procured.

8.1.2. Post Delivery Inspection and Acceptance Sign-Off

The selected Bidder shall depute a technically qualified representative for commissioning/installing the delivered quantity of Laptops, UPS, Printers, External Hard Disk Drives, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams, with respect to category for which contract is awarded, mentioned in this document in presence of the DC (Deputy Commissioner)/designated officer at all locations indicated in this Tender. The DC or his designated officer will inspect the infrastructure deployed and commissioned and fill up the post-delivery inspection report as per the Format 13.11. The successful Bidder, category wise needs to replace the rejected Laptops, UPS, Printers, External Hard Disk Drives, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams mentioned in the proposal with in a time frame of four (4) days from the date of return of the equipment(s). Failure to do so will compel the Registrar, UID, Punjab to impose penalty as defined in the SLA section of this document.

Rejected equipment(s) shall be handed over to the authorized representative of the selected Bidder on the spot. The numbers of such rejected equipment(s) shall be specified in the post-delivery inspection report. The commissioning date will be observed from the day all replacement equipment(s), if any, are delivered to appropriate location and approved post-delivery inspection report for the same, acquired. After the receipt of acceptance sign-off of all the products from all the locations, Registrar, UID, Punjab would issue a letter to the selected Bidder notifying the same. Following which the selected Bidder shall submit invoice to Registrar, UID, Punjab. 36 months of warranty period for all products would start from the date invoice is issued.

8.2. Licenses and Transportation

- 1) All the operating system/software licenses are to be registered in the name of Registrar, UID, Punjab.
- 2) The entire cost of transportation from the Manufacturing Plant or Port of Landing to the designated destination as specified by Registrar, UID, Punjab shall be borne by the selected Bidder.

8.3. Packing

The selected Bidder shall provide such packing as is required to prevent damage or

deterioration of the goods during transit to their final destination as indicated in the Contract. The packing shall be sufficient to withstand, without limitations, rough handling during transit and exposure to extreme temperatures and precipitation during transit and open storage. The Vendor shall be responsible for any defect in packing.

8.4. Invoicing

After the receipt of acceptance sign-off of all the products from all the locations, Registrar, UID, Punjab would issue a letter to the selected Bidder notifying the same. Following this, the selected Bidder shall submit invoice to Registrar, UID, Punjab. The invoice shall be enclosed with the list of serial numbers of the products supplied for a particular location.

8.5. Warranty

- 1) The Selected Bidder is required to provide a comprehensive onsite warranty for the products, category wise for a period of 36 months commencing from the date of invoice.
- 2) The warranty shall cover the system software, pre-loaded software and all the components and sub-components of the supplies infrastructure including patches and upgrades (free of cost) of the system software.
- 3) In addition to warranty as mentioned in above clause, the Bidder shall, during the above said period replace parts, if any, and remove any manufacturing defect, if found, so as to make the system fully operative. Replacement of parts or the entire product is to be done free of cost. Warranty should include parts and the onsite service.

8.6. Reporting of Issues

The successful Bidder needs to provide the contact numbers of the OEM Helpdesk support, email ID and contact number of the successful Bidder's representative and addresses & contact numbers for OEM service centers across Punjab. Any issue encountered with the Laptops, UPS, Printers, External Hard Disk Drives, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams mentioned in this document will be reported to the respective OEM Helpdesk by Suwidha operators and the complaint/case number generated for the incident will be emailed to successful Bidder's representative. It is the responsibility of successful Bidder to track the incident and ensure resolution within the prescribed SLA timelines specified in Section 9. Once incident has been resolved, confirmation email needs to be

sent back to the person who reported the issue originally with a copy to Registrar, UID, Punjab.

In case there is a change in the process for reporting issues, it will be appropriately communicated to successful Bidder. The OEM Helpdesk should be operational during the normal business hours i.e. 10 am to 6 pm during all working days of the week. The OEM Helpdesk operators would have to perform various activities including:

- 1) Understanding the query/issue in the reported request. Query could be related to the following:
 - Hardware including, but not limited to, issues related to any component of Laptops, UPS, Printers, External Hard Disk Drives, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams mentioned in this document.
 - Operating system including, but not limited to, no boot, login and password issues, slow system performance etc.
- 2) Providing information/clarification on the spot in case of an informational query or providing necessary troubleshooting assistance in case of a logged issue.
- 3) Forwarding the case to concerned field engineer if the issue cannot be instantly resolved on the call and is related to any hardware which might need to be replaced.
- 4) In case of technical issues for which a resolution is not possible instantly, the operator will submit the request into the system for escalation and further action by the successful bidder's team.

Section 9: Service Level Agreement

The purpose of this Service Level Agreement (hereinafter referred to as SLA) is to clearly define the levels of service, which shall be provided by the Selected Bidder to Registrar, UID, Punjab for the duration of this Contract. The selected Bidder and Registrar, UID, Punjab shall regularly review the performance of the services being provided by the Selected Bidder and the effectiveness of this SLA.

9.1. Definitions

For purposes of this Service Level Agreement, the definitions and terms as specified in the Contract along with the following terms shall have the meanings set forth below-

- 1) "Incident" refers to any event specifying the defect in any of the categories mentioned in the Section 11 of this document or Operating System problem or problems in preloaded software.
- 2) "Resolution Time" shall mean the time taken (after the incident has been reported at the helpdesk) in resolving [diagnosing, troubleshooting/replacing part(s) and fixing] or time taken to repair a defective computer at the service center.

10.1. Payment Terms

- 1) The successful Bidder will be compensated after adjustments against the penalties levied with respect to the SLAs defined in the Contract.
- 2) The entire cost for supply, installation and commissioning of the IT Equipment-Laptops, UPS, Printers, External Hard Disk Drives, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams along with the 36 month comprehensive warranty for the Contract Period will be borne by the successful Bidder and factored in his Commercial bid submitted in response to this document.
- 3) The Total Contract Value quoted in the Commercial Bid, category wise should cover all costs anticipated by the successful Bidder, on the basis of requirements listed in this document. This would include, but not be limited to:
 - Supply, installation and commissioning of all the Laptops, UPS, Printers,

External HDDs, LED Monitors, Biometric Devices, USB hubs, Spike Suppressors, Android Tablets and Webcams at respective locations. This will be category wise.

- Warranty costs for 3 years after the date of first invoice.
- Any other anticipated costs for providing the Services for achievement of SLAs.
- 4) The successful Bidder will be solely responsible to bear the cost of any items that are not quoted or are under quoted in this Proposal, but are required to meet the SLAs or any other requirements as stated in this document. No additional payment for these components would be made to the successful Bidder.
- 5) The successful Bidder would be paid as per the milestones given in the Payment Schedule.
- 6) For payments, the successful Bidder will be required to raise invoice along with the required documents. Registrar, UID, Punjab will make payment, after the verification of invoice amount, related documents and adjusting for penalties, to the successful Bidder within 30 days of submission of the correct and valid invoice.
- 7) Except as otherwise provided for herein or as agreed between the parties in writing, Registrar, UID, Punjab shall not be required to make any payments in respect of the Services other than those covered in this document and/or Contact.

10.2. Additional Costs

- 1) All payments shall be made after adjustments against SLA based penalties, if any.
- 2) No invoice for extra work/charge order will be submitted by the successful Bidder unless the said extra work/change order has been authorized/approved by Registrar, UID, Punjab in writing.
- 3) Registrar, UID, Punjab shall make payments after withholding tax deductible at source as appropriate.

10.3. Invoicing and Settlement

- 1) The successful Bidder will submit its invoices in accordance with the following principles:
 - Generally and unless otherwise agreed in writing between the parties or expressly set out in this Contract, the successful Bidder shall raise an invoice


